A 50% deposit is required to confirm this charter and must be received no later than 10 days prior to charter. If deposit is not received by the due date, the charter may be automatically canceled without notice. If charter group does not appear on the above date and time or does not cancel the charter by phone, fax, or email or reschedule by phone at least 10 days prior to departure date, then all moneys will be forfeited.

No personal checks are accepted at day of trip departure. Payment may be made in the form of cash, certified check, money order, Visa or MasterCard credit cards.

In the event the Captain cancels a trip due to inclement weather, the Charter Captain may reschedule the trip for the first available date acceptable to both himself and the customer, provided a reasonable amount of fishing time has not been completed. We reserve the right to make whatever changes in the trip that circumstances dictate, including substitutions of boats, and cancellations due to weather, mechanical failure, acts of God, etc.

We do not furnish or sell beer, but it is permissible to bring your own.

Persons under the influence of intoxicants shall, at the discretion of the Captain, be refused permission to board, or required to disembark and trip terminated without refund of any money paid by such person or persons for the charter. No hard liquor is allowed

Glass beverage containers or firearms are not permitted on board.

**ZERO TOLERANCE DRUG POLICY:** Detection of usage or possession of narcotics, including marijuana by any of the charter group, will result in the termination of the charter and forfeiture of all funds..

**ASSUMPTION AND RELEASE FROM LIABILITY**, Client assumes all responsibility and liability associated with their participation or observation of said charter fishing, and further releases and holds Seller harmless from any and all causes of action, suits, and other legal proceedings brought by any third party associated with care, use or maintenance of Seller's fishing equipment or boat and Sellers performance of the agreed upon charter fishing services.

**Personal Safety:** The owners of River Rebel Charters have taken the necessary precautions to provide a safe boating experience, however the ocean has many variables. The owners, managers and employees of River Rebel Charters are not, under any circumstances, responsible for you personal safety. All passengers board at their own risk. Existing medical conditions should be brought to the attention of the Captain prior to boarding.

**FISH:** All fish caught on rod and reel, are the property of the party.

**Tackle/Bait:** River Rebel Charters will provide all tackle and bait. Customers may bring their own rods if they prefer. However, in the event tackle is destroyed or lost through misuse by a party member, the Captain will expect reimbursement.
